

Weather Evaluation Sub-team (WET) - The CSG approved a new task for the WET to submit a proposal outlining the resources required to implement the WET's vision for Operational Bridging (OB) and the Aviation Weather Statement (AWS). The proposal will also provide recommended time-lines for the operational implementation of the AWS. The WET believes that the CDM community will benefit from a collaborated weather forecast process that accounts for all weather parameters that impact traffic flow management (convection, terminal winds, ceiling/visibility, winter ops, etc.). The goal of OB and the AWS is to provide ATM decision makers with the timely delivery of high confidence, high relevance aviation weather constraint forecasts, including those which predict that an anticipated constraint will NOT materialize or an active constraint will terminate sooner than expected. This should allow ATM decision makers to more effectively adjust, initiate, amend or terminate planned or active TFM initiatives, and result in more efficient use of available airspace.

The WET is pleased to announce that the 2013 Operational Bridging Demonstration will be conducted five days a week for the majority of the SWAP sea-

The OB desk will be staffed and issuing AWSes as needed from 6:30 AM to 9:00 PM EDT, Monday through Friday from June 1st to September 1st.
